Harper Government cracks down on businesses using electronic sales suppression software to hide sales

On September 11, 2013 The Honourable Kerry-Lynne D. Findlay, Minister of National Revenue, P.C., Q.C., M.P., was joined by the Honourable Laurie Hawn, Member of Parliament for Edmonton Centre, and Garth Whyte of the Canadian Restaurant and Foodservices Association (CRFA) today to announce new measures to combat the underground economy and the use of electronic suppression of sales (ESS) software.

"Our Government is committed to cracking down those who attempt to cheat the system and ensuring a level playing field for honest businesses," said Minister Findlay. "All Canadians must meet their tax obligations. Businesses that use ESS software to

underreport their revenues and avoid paying taxes are on notice. We will continue to support Canadians who work hard, play by the rules, and pay their taxes."

The use of ESS software undermines the competitiveness of businesses that abide by the rules, as it offers an unfair advantage to those who fail to comply with Canada's tax laws.

"When some businesses cheat, we all lose. These new measures are an important piece of our Government's plan to help Canada continue on its path to economic growth," added M.P. Hawn. Under the new proposals, businesses that use, possess, or acquire ESS software will face monetary penalties of \$5,000 on a first infraction, and \$50,000 on any subsequent infraction. Anyone who manufactures, develops, sells, possesses for sale, offers for sale or otherwise makes available ESS software will face monetary penalties of \$10,000 on a first infraction, and \$100,000 on any subsequent infraction.

Small business tax break on employer health tax

Ontario announces tax relief for small businesses

Small businesses to get break on employer health tax while big business picks up the slack in new bill from Finance Minister Charles Sousa.

Putting on his Robin Hood hat, Finance Minister Charles Sousa wants to ease the employer health tax burden on 60,000 small businesses and shift it to big ones with annual payrolls more than \$5 million.

The savings will be up to \$975 a year, offset by big companies paying as much as \$7,800 more, Sousa said Tuesday before introducing the "Supporting Small Businesses Act" promised in his spring budget. Aside from reducing costs, the legislation would cut red tape for small employers, including charities and not-for profit organizations, that would no longer have to file employer health tax paperwork.

If the bill is passed in the minority parliament, private-sector businesses with annual payrolls of \$450,000 or less will get the break beginning in January.

In total, the employer health tax now raises \$5 billion a year. The proposed change would cost the provincial treasury a fraction of that amount, about \$5 million.
