Operation Christmas Child - The Journey of a Shoebox Every year, for the past 5-6 years, the whole team at Steve Kirkham C.A. volunteers together for a rotation of packing shoeboxes for under-privileged children around the world! And they have a lot of fun doing it! The will sort and check and re-pack potentially hundreds of shoeboxes, making sure that everything in those boxes is appropriate and safe for the intended recipient. They will open shoeboxes that identify whether for a girl or boy, age 2-4, 5-9, or 10-14. They will check for items not allowed to be included and then repack the school supplies, stuffed toys, plastic cars, soaps and toothbrushes, small tools, or

puzzles. It's an amazing feeling to put these boxes together and imagine the child who will open it up and be so happy to see the gifts inside for them!

Operation Christmas Child was started in 1990! To date, Operation Christmas Child has collected and distributed over 100 million shoebox gifts worldwide. In 2014, Canadians donated more than 700,474 Operation Christmas Child shoeboxes for hurting children around the world.

Each shoebox is given to children regardless of gender, race, or religion. When culturally appropriate, copies of a book entitled The Greatest Gift, which has been translated into 130 different languages, are offered to children after the shoeboxes have already been distributed.

You may also contribute to an 'online' version of the shoebox, in case people don't have time to make one themselves, you can put it together virtually.
